

TAB MATCH 3 - TERMS AND CONDITIONS

1. All Entrants (“**Entrants**”) who participate in this TAB Match 3 Competition (the “**Competition**”) are deemed to accept these terms and conditions of entry. Entries that do not comply with these terms and conditions will be deemed invalid and the New Zealand Racing Board (“**NZRB**” or “**TAB**”) takes no responsibility for such entries. All times given in this terms and conditions are references to New Zealand Local Time and all references to currency are referring to New Zealand Dollars.
2. The Competition Entry Period opens at 12:01AM on Wednesday 1 August 2018 and closes at 11:59PM on Friday 31 August 2018 (the “**Competition Period**”).
3. To be eligible for entry into this Competition, an Entrant must:
 - Be eighteen (18) years of age or over from the time the Entrant first participates in the Competition during the Competition period; and
 - Hold a TAB account with the NZRB during the Competition Period; and
 - Have opted to receive electronic promotional material from the NZRB during the promotion period (“**Promo Yes TAB Account**”).
4. The NZRB reserves the right to require any Entrant to produce identification to verify his or her age.
5. The TAB Match 3 Competition comprises a series of thirty two (32) Daily Prize Draws (“**Daily Prize Draw**”) – one (1) Daily Prize Draw will take place on each day of the competition period, and one day after the Competition Period ends. The first Daily Prize Draw will take place on Wednesday 1 August 2018 and the last Daily Prize Draw will take place on Saturday 1 September 2018.
6. Subject to condition 20, to receive an entry into the Daily Prize Draw (“**Daily Prize Draw Entry**”), an Entrant must place one (1) bet, of one dollar or more between the hours of 12:01AM and 11:59PM (“**Promotion Bet Period**”) through that Entrant’s Promo Yes TAB Account on any single day during the Competition Period (a “**Promotion Bet**”).
7. There is a limit of one (1) Daily Prize Draw Entry per Entrant per day. Placing more than one (1) Promotion Bet during any specific Promotion Bet Period will not earn that Entrant any additional Daily Prize Draw Entries in the respective day’s Daily Prize Draw.
8. Subject to condition 20, Should an Entrant not place a valid Promotion Bet during the Promotion Bet Period for any particular day during the Competition Period, the Entrant will not receive a Daily Prize Draw Entry for that day.
9. By 10:00AM the following morning after each day within the Competition Period, the Daily Prize Draw will take place. A minimum of one (1) \$100 TAB account credit prize (“**\$100 Prize Winner**”), plus a minimum of five (5) \$50 TAB account credit prize winners (“**\$50 Prize Winner**”), plus a minimum of ten (10) \$20 TAB account credit prize winners (“**\$20 Prize Winner**”), plus a minimum of twenty (20) \$10 TAB account credit prize winners (“**\$10 Prize Winner**”), plus a minimum of four hundred and seventy five (475) \$5 TAB account credit prize winners (“**\$5 Prize Winner**”) will be randomly drawn from all eligible Entrants that received a Daily Prize Draw Entry

(the “**Daily Prize Draw Result**”). The Daily Prize Draw will take place in the presence of a designated NZRB representative.

10. There is a total prize pool of \$100,000 available to be won throughout the Competition Period, broken out into:
 - Thirty two (32) x \$100 TAB account credits
 - One hundred and sixty (160) x \$50 TAB account credits
 - Three hundred and twenty (320) x \$20 TAB account credits
 - Six hundred and forty (640) x \$10 TAB account credits
 - Fifteen thousand two hundred (15,200) x \$5 TAB account credits
11. Subject to condition 20, by 11:00AM on the day that any Daily Prize Draw has taken place, all Entrants who placed a Promotion bet during the previous days Promotion Bet Period will receive an email from the TAB that contains a website link to the TAB Match 3 website (the “**Prize Draw Website Link**”). The Prize Draw Website Link will be emailed to the email address which the NZRB has registered against the Entrant’s Promo Yes TAB Account. Entrants are responsible for ensuring their email address is up to date, and that they will have access to that email address.
12. For the avoidance of doubt, the Prize Draw Website Link will be deemed to have been delivered to the Entrant on the day and time that it is distributed to the Entrant’s email address by the TAB, as recorded by the email deployment server of the NZRB’s agent Skinny Marketing.
13. An Entrant must click the Prize Draw Website Link to visit the TAB Match 3 website and click ‘PLAY NOW’ at the TAB Match 3 website prior to 11:59PM (the “**Claim Deadline**”) on the day on which the Prize Draw Website Link is delivered to the Entrant in order to reveal if the Entrant is a:
 - (a) \$100 Prize Winner; or
 - (b) \$50 Prize Winner; or
 - (c) \$20 Prize Winner; or
 - (d) \$10 Prize Winner; or
 - (e) \$5 Prize Winner; or
 - (f) Non-winneron that particular day.
14. Each eligible \$100 Prize Winner/\$50 Prize Winner/\$20 Prize Winner/\$10 Prize Winner/\$5 Prize Winner who clicks the Promotion Entry Website Link to visit the TAB Match 3 website and clicks ‘PLAY NOW’ at the TAB Match 3 website prior to the Claim Deadline will receive a single TAB account credit . This will be automatically deposited into the Entrant’s Promo Yes TAB Account that was used to place the original Promotion Bet on the next business day after the Entrant clicks ‘PLAY NOW’ at the TAB Match 3 website.
15. Any \$100 Prize Winner/\$50 Prize Winner/\$20 Prize Winner/\$10 Prize Winner/\$5 Prize Winner who does not click the Promotion Entry Website Link prior to the Claim Deadline on the day on which the Promotion Draw Website Link is delivered to the Entrant will not be eligible to receive a TAB account credit prize for that particular day. With the exception of the Daily Prize Draw conducted on Saturday 1 September 2018, any such unclaimed TAB account credit prizes will be added to the following day’s Daily Prize Draw meaning there may be more than five hundred and eleven (511) TAB account credit Prize Winners on any particular day during the Competition

Period. Any unclaimed TAB account credit Prizes from the Saturday 1 September 2018 Daily Prize Draw will be retained by the NZRB.

16. If an Entrant clicks a Prize Draw Website Link after the Claim Deadline, they will receive a notification at the Prize Draw Website that they have clicked an Expired link.
17. For the avoidance of doubt, any TAB account credit Prize Draw Winners will not be restricted from winning any subsequent daily Prize.
18. The TAB account credit prizes are provided to TAB customers exclusively for the purposes of betting, only winnings from the customer's bets which have been placed using the TAB account credit prizes may be withdrawn as cash.
19. All care will be taken to ensure that the correct Daily Prize Draw Result will be reflected in the Match 3 game illustration when an entrant visits the TAB Match 3 website and clicks 'Play Now'. Notwithstanding what is displayed on the TAB Match 3 website, Entrants will only be eligible for Prizes that are awarded as a result of the Daily Prize Draw Result. Any entrants that are incorrectly shown a winning result (as a result of a technical error or any other reason) will not be awarded the corresponding Prize.

Introductory Bonus Play Day

20. For the first Daily Prize Draw (which will take place on Wednesday 1 August 2018), all eligible Promo yes TAB account customers will be included in the Daily Prize Draw, and receive a Prize Draw Website Link, regardless of whether they placed a valid Promotion Bet or not on Tuesday 31 July 2018. This will only take place on the opening day of the promotion, to launch TAB Match 3 to all eligible TAB account customers ("**Introductory Bonus Play Day**").

General Terms

21. The NZRB reserves the right, at any time, to verify the validity of any Promotion Bet or Daily Prize Draw Entry and to disqualify any person who submitted a Promotion Bet or Daily Prize Draw that is not in accordance with these terms and conditions, or who tampers with the entry process or attempts to act in a fraudulent or dishonest manner.
22. The following persons are not eligible to enter this Competition or win a prize:
 - Board members, employees, agents (and agent's employees) and contractors of the NZRB; and
 - Any "excluded customer" of the NZRB (being a customer who has self-excluded from the NZRB's products/premises, as well as any customer who has been excluded by the NZRB); and
 - Directors, Employees, agents (and agent's employees) and contractors of Skinny Marketing; and
 - Any customer involved in TAB accounts established for a syndicate, commercial or group use.

23. If this Competition cannot be run as planned for reasons beyond the control of the NZRB, the NZRB reserves the right in its sole discretion to cancel, terminate, modify or suspend this Competition.
24. The NZRB takes no responsibility for any inability to enter, complete, continue or conclude the Competition due to equipment or technical malfunction, Acts of God or otherwise.
25. Except for any liability that cannot be excluded by law, the NZRB and any person in connection with this Competition are not liable for any direct, indirect, special or consequential loss or damage whatsoever suffered or personal injury suffered or sustained in connection with:
 - participation in this Competition; or
 - the use of any Prize; or
 - the administration of this Competition.
26. Failure by the NZRB to enforce any of its rights under these terms and conditions at any stage does not constitute a waiver of those rights.
27. Any personal information provided by an Entrant in participating in this Competition will be held in accordance with the Privacy Act 1993.
28. The NZRB will not disclose the personal information provided by Entrants as part of the Competition to any person, organisation, agency or other third party except as provided for by these conditions, under the NZRB General Terms and Conditions, Betting Rules or as may otherwise be required by law. Entrants may request access to their personal information or may request that their personal information be removed from the database, or corrected, by contacting the NZRB.
