In signing this form I confirm that I understand the following :

- 1) The NZ Racing Board Harm Prevention and Minimisation policy dictates the exclusion will apply to both the TAB Wagering and Gaming Machine (pokies) operations.
- 2) Under Section 65 (refusal to accept bets) of the Racing Act 2003 I am excluded from betting using NZ Racing Board wagering systems including, but not limited to, those found at TAB Venues, Race Courses also TAB Accounts.
- 3) Where the Gaming Operator License is in the name of the NZ Racing Board then under Section 310 of the Gambling Act 2003 I will be excluded from using the Gaming Machines (pokies).
- 4) I must provide a clear photo of myself for the purpose of enforcing this exclusion.
- 5) This is a multi-venue exclusion and will be forwarded to all of the TAB outlets in my local area.
- 6) This exclusion will remain in force, and cannot be revoked, for the term specified and until the re-entry conditions are satisfied. Details of re-entry conditions are over page.
- 7) This exclusion may be re-newed and the NZ Racing Board does not guarantee re-entry will be granted.
- 8) Any breach of the exclusion may result in enforcement action being taken which may involve the NZ Police, Department of Internal Affairs and the imposition of fines under Section 312 of the Gambling Act 2003.
- 9) I acknowledge that NZ Racing Board will use reasonable endeavours to enforce the exclusion against me at all times. Should I succeed in gaining entry to into the gaming (pokie) area of a TAB Venue or placing a TAB wager, I will not hold the NZ Racing Board, or any individual employee, liable for the consequences of any visit.

Re-entry Conditions
